# Partnership Update & Action Items

### **Local Tobacco Prevention Updates**

# • Ave Maria Tobacco-Free Campus Initiative

Cris Labra informed the partnership that the Ave Maria University task force has held another meeting. At that meeting C. Labra met with V. Crockett, Director of Residence Life at Ave Maria University. C. Labra informed partnership members that Ms. Crockett requested tobacco prevention educational brochures, as she believes that educating the campus community of the harmful effects of tobacco use will be crucial in gaining support from students and administration. At this meeting task force members also came to the conclusion that an educational table should be set up during one of the school's lunch periods in order to see if the students would be in support of a tobacco free campus policy.

# • Smoke Free Multiunit Housing (SFMUH) Policy Guidance

Cris Labra gave a quick update on SFMUH. Members were informed that C. Labra continues to work with Little Hickory Bay Condominium. C. Labra conducted a presentation geared towards the residents. At this point, the board is conducting a poll to see if there is enough support from the residents before they decide to move forward.

#### Worksites (Tobacco Free Restaurants)

N. Garcia gave an update on the Blue Zones Project (BZP) partnership. The program continues to work with BZP and is assisting several worksites with policy development. As originally planned, N. Garcia informed that signs will be provided to worksites that establish a tobacco free grounds policy.

### • Collier County Public Schools

N. Garcia shared that staff members have met with Collier County Public Schools(CCPS) leadership member, T. Bowen. CCPS has requested that grantee staff visit all Collier County Middle Schools in aims of educating youth about the harmful effects of vaping. Partnership members were informed that staff is currently working with CCPS leadership in developing a lesson plan and will need the partnerships support in executing this activity.



#### **Tobacco Prevention Prioritization Discussion**

• N. Garcia conducted an activity that focused on opportunities, barriers and the readiness of our partnership in conducting certain activities if resources were not an issue. Members brainstormed and came up with activities that they would like to see the partnership pursue. Once a list of activities was created, Nina Garcia asked partnership members to categorize the activities into low to high effort and low to high impact. The partnership agreed that it'd be best if they pursued activities that fell under low effort and high impact. A few of the activities/initiatives that the partnership agreed to pursue were: developing better ENDS resources, creating youth focused PSA's, and pushing for more policy adoption (Tobacco 21).
